* Enrollment Projection Presentation – Mr. John Kennedy – New England School
Development Council (NESDEC) (PowerPoint) – Demographic Information and Enrollment
Projections. Mr. Kennedy presented findings regarding the predicted enrollment for the
Plymouth Public School District.

Dr. Semmel (comment) – Making sure the potential scenarios are made public. There will be
multiple opportunities for the Board and the public to have conversations and comments.
The Board is not looking to do something in the near future or quickly. The goal is to see
there is advanced planning and backwards mapping and to look forward into the future. To
make good decisions now in order to move education in an efficient manner. The Board is
hoping to have as much public comment as possible, so people have an opportunity to
present their input to the Board.

8. **Old Business**

* 2019 – 2020 Budget

MOTION: To approve the 2019 – 2020 Budget with adjustments as presented.
Motion Mrs. Kulesa, seconded Mr. Foote, any discussion.

Dr. Semmel – Town Council approved a budget which requires the Board to reduce the adopted budget by \$128,000.

The following are recommended cuts:

Electricity	\$ 10,000
Savings on Salary	50,000
Saving on Benefits	45,000
Reduction in Supplies	<u>23,000</u>
Total	\$128,000

Mrs. Kulesa (clarification) – If the Board were to take the \$128,000 from the items mentioned (electricity, savings on salary and benefits and reduction in supplies) they would not need to reduce staff? If agreeable to everyone, this would mean that the district would have the additional half-time music teacher at the middle school, leaving Mr. Keane at the high school full-time. An additional teacher to the moving up grade 3 at Plymouth Center School would be added.

Dr. Semmel – The budget that was passed included the teacher at Plymouth Center School.

Mrs. Kulesa – That is not being taken away?

Dr. Semmel – Correct. He feels it is important to keep a track on the class sizes up until the August Board Meeting. Dr. Semmel shared with the Board the current class sizes are for this year and what they would be next year based on our recommendation for the cuts to be made tonight. The grade 3 classroom mentioned for next year reduces to classes of 13 students in each class. Recommendation to have an additional 3rd grade class and 3 second grade classrooms.

Mr. Elsaghir – Was one of the public commentors made regarding the proposal does not include the teacher?

Mrs. Johnson – The individual may have had a previous document and not a current one.

Dr. Semmel – If the individual was reading the Potential Budget Reduction, he may have misread it.

Walt Seaman – Just for clarification. Your proposal – 3 teachers at the 2nd grade for Plymouth Center and 2 teachers at the 3rd grade?

Mrs. Kulesa – That is what we have in the budget.

Mr. Bourbonniere – Questioned to Mr. Hendrickson and Dr. Semmel regarding the Accounts-by-Facilities Report especially the section on the cost of the copiers and the amount of money not spent on the copiers. Mr. Hendrickson to look into this matter.

Mr. Foote – move the question.

MOTION: To approve a transfer in the amount of \$301,456.00 from the Special Ed Outplacement Account to Special Ed Salary Line. Motion Mrs. Kulesa, any discussion, all in favor, opposed, Mr. Bourbonniere, abstentions. Motion passes.

MOTION: To approve a transfer in the amount of \$50,000 from Health Insurance and Consultant Services to our legal fees account. Motion Mrs. Kulesa, any discussion,

Mrs. Candrea-Florenciani - \$50,000 worth of equipment listed for next year. If there is extra money, she feels it should be put towards education or supplies that is needed for the schools. It is in our budget for next year that this account will be getting money in the budget.

Dr. Semmel – We are confident that we will have some additional bills above and beyond what we budgeted for legal for next year. Rather than putting us in the red, we would have that money. If for some reason we do not use this money, the Board may transfer it at that time to another line.

Mrs. Candrea-Florenciani – If we had \$60,000 left over, we cannot carry it over to next year. So, if we put \$50,000 into legal fees how would we be able to have that next year?

Dr. Semmel – We are allowed especially when we have expected legal fees, to send Shipman & Goodwin a retainer. Therefore, it will not be in our budget any more.


