9. **Superintendent's Update**

The Tooth Fairy Trap

\* Plymouth Center School was awarded the Phyllis Corsetti Grant from the Terryville Public Library in the amount of approximately \$1,600 for their One School, One Book Program. This grant was written by Mrs. Worhunsky.

About the Project:

- \* Each classroom received a book, The Tooth Fairy Trap which the teacher read aloud to the children.
- \* The author of the book visited the school.
- \* 212 students participated in a STEM activity by designing their own Tooth Fairy Trap from recyclables from home.
- \* Overnight, the Tooth Fairy visited Plymouth Center School and left a message behind for each student in each of the Tooth Fairy Traps.

Mrs. Worhunsky (Plymouth Center School)

Mr. Falcone expressed how grateful he was to Mrs. Worhunsky for stepping into the principal position at Plymouth Center School in our time of need. She is an amazing leader and individual. This district cannot thank her enough for all she has accomplished for the faculty, staff, parents, and children in our district.

Dr. Bonnie Doughty-Jenkins (Eli Terry Jr. Middle School)

Mr. Falcone thanked Dr. Bonnie Doughty-Jenkins for the time and effort she put in before, during and after school working with our students. She trained the entire 8<sup>th</sup> grade class in "Hands-Only" CPR and helped 12 students receive their CPA, AED and First Aid certifications.

Scholarship Night

Annual Scholarship Night took place on May 26, 2022 at Terryville High School. Mr. Falcone thanked our local businesses, community members and organizations for their support and investments in our students. All totaled, our seniors received approximately \$250,000 in one time and renewable scholarships.

Exiting of the State Partnership Insurance Plan

The district is in the process of looking to exit the State Partnership Plan. We have entered an RFP with 6 other organizations and found that United HealthCare can match our current benefit program.

Cost Savings: The State Plan is increasing 10% next year while the United Plan would only increase 6.47% and would be capped at 8% the following year.

Again, Mr. Falcone indicated that he and Mr. Tencza will be sharing more specific information with the Board at the August meeting.

In conclusion, Mr. Falcone, based on the horrific situation that occurred in Texas, assured the Board and parents that the district will continue to focus on our number one priority, the safety and wellbeing of our faculty, staff and students. The district will focus on purchasing additional resources and modifying protocols and procedures to keep our schools safe.

Mr. Falcone thanked the Board and the community for their support in his first year as superintendent. It has been an interesting year. As a Board much was accomplished this year and the district is moving in an unbelievable direction. The Board should be proud of their accomplishments and he is proud to be a part of this team. A. **Out of State & Out of the Country Field Trips**

MOTION: To entertain a motion to approve an out of the country field trip to Iceland to provide students in grades 10 – 12 an opportunity to participate in the Explore Iceland Tour with the EF Tour Company.

The group will travel to two cities in Iceland with an expert tour guide over a span of 7 or 8 days. The students will learn about tectonic plates, geothermal energy, visit a Viking town, and walk on a glacier. The proposed trip will take place either April vacation of 2023 or June of 2023. A. **Finance/Operations** - Mr. Tencza, Business Manager

Mr. Tencza apologized for the typos in his report. He then addressed the cafeteria price increases. After discussions with Mr. Falcone and the Food Service Director, it was felt it is in the best interest of families not to have a price increase for the school lunches at this time. With the rising cost of inflation, we, as a district, do not want to add another burden to the families. However, he indicated he has heard the State is going to allocate \$30 million for free meals in 2022 and 2023, but feels the amount the district will receive will not cover the entire school year but will help.

Mr. Seaman – Mr. Seaman felt the right decision was made.

Mr. Perugino – The meals some of the students receive at school is possibly the only healthy meal they will eat all day. He is happy there will be no price increase.

Mr. Seaman – The cafeteria workers in all of our schools, even thru COVID, really stepped up and went above and beyond their job. Mr. Perugino, you had a question earlier. Did we answer that for you?

Mr. Perugino – I had a question regarding bonuses. Were the cafeteria workers given a bonus?

Mr. Seaman – Mr. Tencza was asked to comment on this.

Mr. Tencza – Mr. Tencza explained that based on the success of the program, the district was only allowed to carry over so much money. It was obligated to reinvest back into the program. This was done through the purchase of new equipment, trying to do some things for the cafeteria workers for their facilities and so forth. During a conversation with Mr. Falcone, Mr. Tencza indicated there was still some money left over.

While purchasing a piece of equipment would be great, he suggested why not invest in our cafeteria workers. These individuals are the lowest paid employees in the district. Mr. Falcone was in agreement. It was proposed to give our cafeteria workers a bonus which amounted to essentially, for this year \$50 a month. If done over the course of 2 years this would amount of \$25 per month. Both Mr. Falcone and Mr. Tencza informed Mr. Seaman who agreed and felt the district should take care of its people, if we can. But they also need to understand that the district is not able to do this all of the time.

Mr. Perugino – Mr. Perugino explained he had no problem with taking care of the district's workers, however, he indicated he would have probably brought this to the Board. By doing so, if any Board Member was approached regarding this matter, they would be able to respond. He was thankful and appreciative for the information.

Mr. Tencza (to Mr. Seaman)– Front sidewalks – The day before yesterday, he heard it was assigned to a contractor and they will begin work. That was his understanding. It came from the town.

Mr. Seaman – We will talk about that after.

Mr. Falcone indicated he has taken and returned all calls. Individuals are very understanding and relieved to know that we all are prepared for whatever may come our way.

Mr. Perugino indicated legislators are speaking about one door. They do not realize that more than one door is needed for egress for safety purposes.

Mr. Seaman indicated as a district we need to make educated and informed decisions. Things need to be sustainable.


