### 8. Superintendent's Update

\* Mr. Falcone welcome back and hope everyone found time to rest and relax during the holiday season.

Mrs. Melillo - Director of Pupil Personnel & Special Education

Prior to the holiday, snowflakes were made by Mrs. Tammy Card's transition students and placed at each Board Member's seat.

Reported on a new program that has been started at Terryville High School. Advisors, Pat and Christine Norton. Unified Buddies provides an opportunity for students of intellectual and developmental disabilities the opportunity to come together with other students and socialize. The first event, which took place before the holidays, nine students attended. They made holidays ornaments, listened to some Christmas music, talking to each other discussing their common interests, their favorite snacks and sport teams. One comment from a parent indicated her son enjoyed the event and it was really nice to watch all the kids come together and socialize. The next place is something athletic, sports related in the gym. Although no date has been set, she indicated when one was chosen she would contact any Board Member who was interested in attending. Many athletes have signed up to participate. There are plans to incorporate more events for this year and next year.

\*Mr. Falcone reported on January 25th, Eli Terry Jr. Middle School and Terryville High School will hold a student assembly entitled, *Chainsaws, Cheeseburgers and RockN'Roll*. He thanked Ms. Alyssa Glaser, Career Counselor for organizing this event and Mr. Marty Sandshaw and the Terryville Lions Club. Mr. Sandshaw brought forth a proposal in support of this assembly to the Lions Club and within 24 hours confirmed that they would donate \$1,000 to pay for this school initiative. We thank them for their generous donation and continued support.

## 10. Board Member/Committee Reports

A. Finance/Operations - Mr. Tencza, Business Manager

Summary of Monthly Budget Report - handed out by Mr. Tencza

This report will be included in the monthly Board of Education Packet. In development of this year's budget, it became very apparent to Mr. Falcone and Mr. Teneza that the budget is really driven by basically ten categories: Administrative Salaries, Certified Salaries, Non-Certified Salaries, Benefits, Contracted Services, Utilities, Transportation, Tuition, Supplies, Facilities and All Other Expenditures. He took the budget and broke it into these ten categories in order for the Board to see how we really go with those categories and how we are spending the money throughout the year. Anything that falls into a supply line, whether it is maintenance, facilities related, curriculum and all other expenditures. Mr. Teneza will update this report on a monthly basis. The report will show where the budget is falling in those particular categories. This is another way to look at how the money is being spent. There is \$57,000 in the budget for a second vehicle for the district. But, more than likely this will be cancelled. Substitutes and summer school run through all other expenditures at this point. These will more to other categories, non-certified at some point. Both are running at a deficit this year. All other expenditures may change in the future.

Mr. Perugino – Pages 2, 4 and 7 – <u>Custodial Supplies</u> on the Accounts-by-Facilities Report – are we over \$16,300. Is there a reason?

Mr. Tencza – We are. Custodial Supplies are currently running over last years' expenses. We do have a limited amount of supplies. We need to purchase more to get through the year. We should be okay. Example: We were paying \$50 for a gallon of wax last year. This year the price has gone up to \$125.00 a gallon.

 $\underline{\mathsf{Mr. Perugino}} - I$  do not see any revenue. Is there any revenue, like when we rent out the school? Is there a line item for revenue?

Mr. Tencza – Most revenue for rental all into the activity account fund not the operating budget. If there is revenue that runs through a line, it is not shown as a revenue line. Example: Excess costs-reimbursement could be considered as revenue. We budget as a net not revenue.

Mr. Perugino – Do we do much rental. When my son was in Karate, we rented the place out and paid for the janitor. Do we still do this?

 $\underline{\text{Mr. Tencza}}$  – Pre-COVID that may have been true. But Post-COVID, there is not a lot of that type of use. Booster Club and PTA may use it.

Mr. Perugino - Does Park & Rec use it? Do they pay for the gym?

Mr. Seaman – No. So, a while ago, the Board made a decision not to charge Park & Rec up to a certain dollar amount. There is an MOU. So, we go back and forth. So, this year it is going to be a little different. February vacation, school is closed and the janitors are not going to be here. Park & Rec schedule goes into February vacation. What Park & Rec was told is if we can find a janitor to work and they are going to cover the salary of the janitor, the school will be opened. If no one will work and Park & Rec is not willing to pay the salary, the school will not be opened. Park & Rec agreed to pay the salary. No problem.

Mr. Perugino – I don't know why. I guess here is my question, Walt. When my son was in karate, which is part of Park & Rec, I had to pay every month. So, if the Park & Rec Department is collecting every month, why are we giving them the gym?

Mr. Seaman – Because, what we did Pat is, because we were more community based. So, what we had said in the MOU and we voted on it as a Board, is that as long as they up to \$10,000 it comes down to the benefit of total because not every child can afford to pay Park & Rec. So, now you have more kids. So, the deal was that they had to take that \$10,000 and they have to do something else for the town. It was not for them to keep, or show profit or for salaries. They had to put the money back into the community and they are doing that.

Mr. Perugino - They are doing that?

Mr. Seaman – Yes. So you will see a fishing derby coming up and they are going to buy, what I'm being told and I don't want to speak on their behalf. But they are going to buy fishing poles and stuff for the kids.

Mr. Perugino – We had that before. We always had a fishing derby.

Mr. Seaman - Yeah, but was that Fish & Game?

Mr. Perugino - They had summer programs at Main Street School. They had all that.

Mr. Scaman – So, that's different. The summer camp, they still get charged. That is still an expense to them. I do not want to say revenue for us. But, they still cover that expense.

Mr. Perugino – But, the way the budget is right now, Mr. Chairman, I am going to have to take a really good hard look at what is going on. Something just does not seem right. I know I had to pay every month. When I was sitting in your chair, if anyone wanted to use the facility, they had to have 51% of the kids had to be from town. I know we had a big problem with the girls' softball league because they were bringing in girls from out of town. That was fine. But we could not get the 51% and there was a big battle.

Mr. Seaman - So, I think what you are going to see on the town's side, again, I am not speaking for them, but you are going to see a collaborative effort with Parks & Rec, Bristol and Thomaston.

Mr. Perugino - I hope so. I am going to keep my eye on that. There is something not registering in my head, but it will.

Mr. Falcone – I would also recommend checking the Board Policy. Remember when we adjusted policy (Shipman & Goodwin), the language had a bit of flexibility. I am speaking more regarding the 51%. I think that, I do not know if that is still in the language.

Mr. Perugino - Other than that Matt, we have 2.4 million left? Am I right or wrong?

Mr. Tencza - Correct

Mr. Perugino - Thank you
