Vaccination Update for School Personnel: Mrs. Turner indicated she has weekly meetings with the Department of Health and the Torrington Health District. Currently, the Governor has opened the eligibility window for individuals 65 and over. Carolyn Giannini, District Nurse Coordinator and VAMS Coordinator has uploaded those school personnel who are 65 and over into VAMS and has contacted them as well. If you have changed your mind and would now like to receive the vaccine, please contact Nurse Carol. Expected timeline for vaccinating all other school personnel may not be until March or April at this point.

<u>Ms. Aronheim</u> – Director of Pupil Personnel & Special Education Services - Prek Lottery to open February 12<sup>th</sup>. If you have a child who is going to be 3 by the end of December, your child would be eligible for the district's PreK Program. One does not have to have any documents ready, just put the demographic information into the Lottery System. If accepted, you will be notified. Due date of March 9<sup>th</sup> to be accepted.



Mrs. Turner - Kindergarten registration to follow soon after the Prek Lottery.

<u>Mr. Elsaghir</u> – Did you say everyone would be vaccinated by March for all teachers that want it? I didn't hear all of it?

<u>Mrs. Turner</u> – So what we have been told, the timeline is 65 and over right now. What they are telling us is as far as all school personnel that are under 65, we would not expect them to start to be vaccinated until March, probably into April.

<u>Mr. Seaman</u> – One of the items we discussed with Nurse Carol and Mrs. Turner, if we are able to get the vaccinations secured, as soon as those teachers become eligible, we are going to try and vaccinate in house which will make it easy and simple and hopefully we can streamline the process and get this done as quickly as possible.

Mrs. Turner - It is school personnel. So everyone that works for the district is eligible.
