6. Superintendent's Update

\* Sad News – The passing for Larry Amara. Mr. Amara was a 35- year educator for the Plymouth Public Schools. He passed away on Tuesday, November 20, 2022. He was Business Teacher, School Counselor at the high school and the Principal of Plymouth Center School for 23 years. Our thoughts and prayers go out to his wife, Laura, and his family.

\* NEASC Update

Our high school is accredited through the New England Association of Schools Colleges. On December 13, 2022, we were informed that the NESAC Commission on Public Schools has continued our High School's accreditation. The next step in this process is to complete a 5- year report updating the Commission on our work with the Portrait of the Graduate. This 5-year report is due on February 1, 2024.

\* International Partnership

The Board was provided with the high school and district brochure that we will be utilizing for our international partnership. The next step in this process is finding an international partner. However, for the time being, this initiative has been placed on hold as this is going to be a very difficult budget season. Before moving forward, it is important the Board confirms this is a priority in the 2023 – 2024 budget.

4. Community Service Requirements

Mr. Tencza – Summary

- \* All Budget, All the time
- \* We are currently in a Budget Freeze (inflation, cost of utilities, fuel and increased tuition (not only special education but magnet schools as well)
- \* Bar Graph shows the highest spending we had in November at this point in time – anyone having an expenditure needs to contact him directly. Regular operational needs will be put through. If there is something that can wait, that is what will be done.
- \* Food Service – Another good month for November. Food Service continues to do well in our district. Smart Funding from the state, which supplements our revenues expires in December. However, the Board agreed to continue to fund the children through the end of the school year. An additional \$26,000 was received to help offset costs and inflation for certain products used in the cafeteria.
- \* Those districts where funding is running out have seen a drop in participation of up to 75% and not for just those students who need to pay but the free and reduced lunch participation also. Students are not taking lunch.
- \* Projects Finishing Up
  - Painting complete
  - Scoreboards done, wired and ready to go for the spring
  - Middle school scoreboard shipping on January 2, 2023
  - Auditorium still waiting for parts

Floor opened up to any questions

Mr. Perugino – Furnishings – Is that when we had to redo the middle school for the culinary program?

Mr. Tencza – No, the number there for furnishings is for the new kiln.

Mr. Perugino – Page 13 – Outplacement – Non-Public

Mr. Tencza – No need to worry. Excess Cost Grant 1<sup>st</sup> payment in February which will offset the negative number.

Mr. Perugino – Special Education Summer School

Mr. Tencza – Needs to make transfers.

Mr. Perugino - \$3.2 million left in Budget?

Mr. Tencza – Keep in \$12.5 million encumbered, all salaries, transportation encumbered.

Mr. Perugino – There are things we have no control over, fuel oil, electricity – 55% from last year. We cannot control Special Education, diesel, heat oil. We are in a bad place.

Mr. Falcone – To be fair to the community and the town, these are hard times for everyone. Inflation has hit everyone hard. We need to sharpen our pencils and do what we can to put up a fair budget that is supportive of our schools and our district but also supportive of the town and community.

Mr. Perugino – Need to get pro-active on outplacement.

Mr. Falcone – The expenses of those schools go up and they just bill us. Our expenses go up but we cannot bill anyone. That is what is happening with our Athletic Trainer, Transportation, etc. It is going to be a challenge.

Mr. Perugino – Capital Improvements – Thinks the town is going to have to (inaudible) .....

Mr. Falcone – Partnerships have never been stronger or better.

Mrs. Kulesa – Getting back to the lunches. Has there been any discussion or legislation, Universal Free Lunches.

Mr. Tencza – Article he referred appearing in the Hartford Courant does speak about a representative who is going to introduce legislation in Connecticut. Five states already embrace this nationwide. Universal Free Lunches for all schools. Some have adopted Universal Free Lunches for this year only.

Mr. Seaman – In the article does it look like it will be funded?

Mr. Tencza – They would need to provide funding somehow.
