- Update on the 2018 – 2019 Budget
 - * March 15, 2018 – The Board presented the Board of Education adopted budget to the Plymouth Board of Finance (\$24,235,436, about a \$22,000 increase (.09%) over the current budget.
 - * April 2, 2018 the Plymouth Board of Finance met and voted to reduce the budget by \$197,000. (reduction to about .7%) Currently, we are reviewing insurance carriers and looking at possible savings, however, this is not finalized. Addressed the assumption of the \$8.5 million from the ECS Grant

- Non Tenured Teacher(s)

MOTION: To approve the non-renewal of contract of employment of Samia Issadi, French Teacher at Terryville High School and that said contract not be renewed for the following year upon its expiration at the end of the 2017 – 2018 school year due to budgetary constraints. The Superintendent of Schools is hereby directed to advise such person in writing of this action. - Healthy Food Certification 2018 – 2019

All public school districts participating in the NSLP must submit the *Healthy Food Certification Statement – Addendum to Agreement for Child Nutrition Program (ED-099)* by July 1, 2018 to certify whether or not all food items sold to students will or will not meet Connecticut Nutritional Standards.

- **Healthy Food Option:** Pursuant to C.G.S. Section 10-215f, the board of education or governing authority certifies that all food items offered for sale to students in the schools under its jurisdiction, and not exempted from the Connecticut Nutrition Standards published by the Connecticut State Department of Education, will comply with the Connecticut Nutrition Standards during the period of July 1, 2018, through June 30, 2019. This certification shall include all food offered for sale to students separately from reimbursable meals at all times and from all sources, including but not limited to, school stores, vending machines, school cafeterias, and any fundraising activities on school premises sponsored by the school or by non-school organizations and groups.

MOTION: To implement the Healthy Food Option. Motion Mrs. Kulesa, seconded Mrs. Kremmel, all in favor, opposed, Mr. Elsaghir, any abstentions, motion passes.

If the board of education or governing authority votes “yes” for the healthy food option above, the board of education or governing authority **must also vote** on whether to allow food exemptions, as indicated below. **NOTE:** *If the board of education or governing authority votes “no” for the healthy food option above, a vote on whether to allow food exemptions is not required.*

- **Exemption for Food Items:** The board of education or governing authority will allow the sale to students of food items that do not meet the Connecticut Nutrition Standards provided that the following conditions are met: 1) the sale is in connection with an event occurring after the end of the regular school day or on the weekend; 2) the sale is at the location of the event; and 3) the food items are not sold from a vending machine or school store. An “event” is an occurrence that involves more than just a regularly scheduled practice, meeting, or extracurricular activity.

For example, soccer games, school plays, and interscholastic debates are events but soccer practices, play rehearsals, and debate team meetings are not. The "regular school day" is the period from midnight before to 30 minutes after the end of the official school day. "Location" means where the event is being held.
